ADVISORY-2

Sir,

Sub: Preventive measures to contain the spread of Corona Virus-Reg.

It is to inform that some of the employees of the zone have been tested positive for Covid-19 or they are having flu like symptoms akin to that of COVID-19. In this regard attention is drawn to the Lettrdt. 12.06.2020 wherein it was requested to share the details of all the employees or staff, who are on sick leave. In continuation to the above the following advisory is issued;

- 1. Wherever an employee is reported sick with flu like symptoms, he should be advised to seek medical help immediately and the COVID volunteer nominated by the Commissionerate should be regularly in touch with them . In case symptoms persists or worsen, the necessary action/help should be extended to get the employee tested for Covid-19.
- 2. In case the Covid-19 test is positive, the employee should be advised to home quarantine or hospitalisation as perrecommendation of the treating doctor based on his/her symptoms. In case of mild symptoms and where home isolation is advised, the employee shall stay home and follow the homeisolation protocol. The COVID volunteer of the Commissionerateto extend all support to the affected person and his family in organizing medicines/ essential supplies etc.
- 3. In such a scenario all primary contacts with whom the employee has interacted in the previous 2 days before becoming sick to be prepared and all such employees should be advised to undergo mandatory self-quarantine for 14 days. The details to be shared with

the COVID volunteer who shall monitor the health status of all such employees. In case anyone develops flu like symptoms he/she should be advised to get medical help/ get tested for COVID-19.

4. All other officers/staff who are secondary contact shall work from home for at least one week and also monitor their health status as per

the protocol.

5. Necessary action shall be initiated to disinfect the office space/vehicles as per the SOP issued by Ministry Of Health and Family welfare, Govt. of India. In this regard the fumigation services of central warehousing corporation may be availed off (Technical officer CWC ShriChandrashekhar Ph. 8919691354)

6. The AddI./Joint Commissioner (P&V) shall keep the undersigned informed regarding all such employees/staff on a regular basis.

7. List of COVID Volunteers and the accredited laboratories in Telangana for conducting COVID-19 test are enclosed.
