PUBLIC NOTICE NO.10/2020

Subject: NOC for release of Infrared Thermometer due to spread of COVID-19 pandemic relaxation in procedure under Legal Metrology Act, 2009 – regarding.

Attention of the importers, trade, Customs Brokers and all the stakeholders is invited to clarification No.I-9/20/2020-W&M Section dated 07/04/2020 issued by the Deputy Director, Legal Metrology, Ministry of Consumer Affairs, Food and Public Distribution, Government of India on compliance of provisions of Legal Metrology Act, 2009 and Legal Metrology (Packaged Commodities) Rules, 2011, as applicable to Infrared Thermometers (Electrical Thermometers).

- In view of the said clarification dated 07/04/2020, the importers may clear the 2. consignment of Infrared Thermometers with the condition that they will comply with all the requirements of Legal Metrology Act and Rules made there under within three months of the clearance. Format of undertaking to be furnished on the letter head of the importer is enclosed to this PN.
- Importers availing this facility shall ensure that the undertaking furnished in lieu of bond 3. is duly replaced with a proper bond before 15/05/2020. The Assessing Officers shall keep record of such undertaking and ensure that the undertaking is duly replaced by proper bond within the stipulated time period i.e. 30/05/2020.
- All the trade associations/ members of Customs Brokers Association are requested to take 4. note and publicize the contents of this Public Notice among their members / constituents.
- For the departmental officers, this may be treated as Standing Order. 5.

Difficulty, if any, faced in implementation of this Public Notice may be brought to the 6. notice of the Additional/ Joint Commissioner of Customs of the formation.
