Please refer to this office Advisory No.28 issued in File C.No.IV/26/80/2018-Systems (S) dated 18.11.2019 on the above subject.

2. As detailed in the above Advisory, “View Non-Filers (New)” was made available in the ACES-GST application for the field formation on 18/11/2019. With the functionality, the Range officer can issue notices (in Bulk) under Section 46 (read with Rule 68 of the CGST Rules) to the non-filers of Returns under Section 39 of the CGST Act. Additional feature to initiate Suo Moto cancellation (in Bulk) was also added in the functionality on 19/12/2019 (Please refer Advisory No.38/2019).

3. In this regard, a daily report (providing the details of progress made by the field in initiating the GSTR-3A Notice, Number of Returns filed as a result of the

Notices, No. of Suo Moto cancellations initiated etc.,) is being generated and is being shared to all the Chief Commissioners. The report for 10/01/2020 is attached for reference.

4. This report may please be used to monitor the progress made in issuing GSTR-3A Notices, Number of returns filed as a result of the Notice, No. of Suo Moto Cancellations initiated etc., by the field officers and in gauging their performance in this regard.
