RETURNS – GSTR-3A ((NOTICE TO NON-FILERS) ADVISORY NO. 28 (V.2)

Sub: Returns – Non-filers of returns under Section 39 – Issue of GSTR-3A notice under Section 46 – functionality in GST-ACES application – issue of advisory – Regarding.

A functionality "View Non-Filers (New)" was made available in the ACES-GST application for the field formation and an advisory was issued on 18.11.2019.

- 2. With the above functionality, the Range officer was able to issue notices under Section 46 (read with Rule 68 of the CGST Rules) to the non-filers of Returns under Section 39 of the CGST Act upto the month of September 2019. Now the list has been updated and the non-filers of GSTR 3B upto the return period of November 2019 have also been made available.
- 3. For a clear understanding of the above functionality, a detailed user manual with screenshots which was attached with the earlier advisory may please be referred.
- 4. It is requested, that this Advisory may kindly be circulated amongst all officers for effective issue of GSTR-3A notices for the months of October 2019 and November 2019 also and subsequent actions as required under the law.
