2. This report has been generated keeping the Financial Year 2018-19 as the base year. The report provides details of C/D/R; GSTIN, Name of the Taxpayer, Cash deposits (full F.Y.2018-19), Cash Deposits made during December and upto December for 2018 & 2019, Cash set-off & ITC set off during 2018-19 (full FY) and during and upto November for 2018 & 2019.

3 The data is in Excel form; each sheet named with Zone name and each Zone contains data of Commissionerates falling under that Zone. While the taxpayers contributing to the 80% of respective Commissionerate's revenue is given GSTIN wise, contribution of the remaining taxpayers is given in the last row as "total other".

4. We plan to generate this report every month in the 4<sup>th</sup> week and place it in the Antharang.
