

This office reserves right to cancel the ad hoc promotion and revert the officer at any time to the post from which the officer was promoted.

5. The promotions of the Inspectors of Central Tax & Customs to the grade of Superintendents are subject to the outcome of various SLPs pending in the Hon'ble Supreme Court on the issue of seniority in the grade of Inspectors and any other orders of Hon'ble CAT/High Courts on the said issue.
6. The promotion of the officers is subject to outcome of W.P.C.T No.261 of 2008 filed by Shri. Samiran Roy & Ors. Vs Union of India & Ors before the Hon'ble Calcutta High Court and any other litigations, if any, the issue of seniority / promotion pending before any other judicial fora.
7. The above officers are being posted on **in situ basis**. They should join latest by 10-09-2018, positively. If they fail to join by 10-09-2018, it will be deemed as their refusal and the promotion order will be cancelled without any further intimation.


