- 2. The above ad hoc promotion will not confer any right for regular promotions; and the promotion shall be "until further orders". This office reserves right to cancel the ad hoc promotion and revert the officer at any time to the post from which the officer was promoted.
- 3. The above promotion to the cadre of Superintendent is purely on Ad hoc basis for a period of six months from the date of joining in the cadre and this does not confer on them any right to claim for regular promotion or any other service benefits or seniority.
