With reference to letter F.No.NACIN/ZTI/CHD/Staff/01/2017 dated 29-01-2018 received from the NACIN ZTI Chandigarh, Smt Neetu Gupta, Tax Assistant, Secunderabad GST Commissionerate, Hyderabad is hereby transferred to the National Academy of Customs, Indirect Tax & Narcotics (NACIN) ZTI Chandigarh, on "Loan Basis" for a period of two years from her date of joining, on the following terms and conditions:

- (a) While working in NACIN ZTI Chandigarh, all kinds of payments to Smt Neetu Gupta, Tax Assistant towards her pay and allowances will have to borne by her parent Commissionerate. She will not be entitled to any kind of special pay, allowance, etc.
