

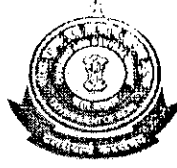

This is to kindly inform that Musheerabad Division has brought certain issues to the notice of the under signed with regard to the Office Premises located at "H.No.1-1-445, 3<sup>rd</sup> Floor, Deccan Residency, Kavadiguda, Hyderabad – 500020". Among other things, the basic amenities like drinking water supply, common Power backup and Generator to Lift are not up to the mark. Further, in entire building only 3<sup>rd</sup> Floor is occupied and remaining floors are empty. The land lords paid scant attention towards maintenance of the building. This necessitated shifting of Musheerabad Division along with Musheerabad Range located in above premises.

As a stop-gap arrangement, the vacant space available in the premises wherein presently Secunderabad Division is situated, is considered for shifting of Musheerabad Division and Musheerabad Range. Accordingly, a Trade Facility bearing No. 03/2020-Central Tax, dated 03.02.2020 has been issued.
