This is for information of the taxpayers and other stake holders that e-Office, an application developed by the National Informatics Centre under the Ministry of Electronics and Information Technology, Govt. of India, to carry out office work electronically, has been launched in the Secunderabad GST Commissionerate w.e.f. 30.07.2020. The application is designed to establish a paperless environment in Government offices, increase efficiency, transparency, effectiveness, employee convenience and accountability and to give better services to the taxpayers and other stake holders.

- 2. It is expected that adoption of e-Office to carry out office work will bring in its wake an attitudinal shift and awareness and usher in more efficient, effective and transparent inter and intra government transactions. The process will benefit the public in terms of enhanced transparency, increased accountability, assured data security and integrity and is also expected to be huge transformation in work culture and ethics within the department.
- 3. With the launch of e-Office, taxpayers and other stake holders are encouraged to utilize electronic means of communication with the Department. In this regard, it may be noted that since e-Office application requires pdf files, it would be convenient if communications/letters sent to the Department through electronic means are in pdf format, better still if they are in searchable mode, for faster processing by the Commissionerate, Divisions and Ranges. The email id of the Commissionerate, Divisions and Ranges are given in Annexure to this Trade Notice. It is requested that all communication to the Commissionerate, Divisions and Ranges may be sent only to the designated email id as given and no other email id. Sending communication on the designated email will ensure that it is invariably attended to by the Commissionerate, Divisions and Ranges.

- 4. Taxpayers and other stake holders are encouraged to mention their mobile number and email id in their communications to facilitate immediate acknowledgement by mail and SMS through the application. They will receive the Diary Number allotted to their communications, which can be used as reference by them while communicating with the Department in future.
  - 5. All the members of the Grievance Redressal Committee, Trade Associations and Chambers of Commerce in the State of Telangana are requested to circulate this Trade Notice among their constituent members for vide dissemination.
